



The following resolutions moved by Prof. M.D. Karvekar, Shri B. Rajan and Shri M. Venkata Reddy and seconded by Prof.O.P. Kalra, Shri Uttam Chandra Mishra and Dr. V. Gopal were unanimously passed applicable in respect of all approvals u/s 12 of the Pharmacy Act, 1948 for the purpose of registration as a pharmacist.

A. For the approval u/s 12

- "(1) In pursuance of the provisions of sub section (1) of section 12 of the Pharmacy Act, 1948 (8 of 1948), the Pharmacy Council of India declares the course in Pharmacy (as applicable) conducted by institutions mentioned below to be an approved course of study for the purpose of admission to an approved examination in Pharmacy (as applicable) in respect of number of students and academic session as specified here under:
